2. Applications are reviewed individually based on photos and written description of products or services to be offered. Vendors will be selected based on space availability as well as product / service distinction.
3. This tournament is sponsored by Ringside boxing equipment therefore all vendor applications will be reviewed to ensure they are not in direct competition with this sponsor, conditions as agreed to by Ringside.
4. Booths/tables may not be shared; anyone selling their wares must go through the application process.
5. Events Permit - You will be required to apply for a temporary event permit in advance. The application will be provided to you with your approved vendor agreement.
6. All products will be displayed in a clean and safe manner.
7. Vendors are responsible for leaving a clean area at closing.
8. All vendors shall exhibit professional manners always.
9. Tables are available
10. Spaces shall be assigned by the Tournament Director.

ADDITIONAL VENDOR INFORMATION

1. Your booth must be open and staffed during all hours of the event on the days you are signed up for including the bonus day for those who this applies to.
2. You are responsible for keeping your booth and area clean at all times. All trash must be properly disposed of.
3. Sales Tax - You will need to collect sales per Nevada Administrative code 372.180.
4. All sales are from your assigned booth. No roaming sales.
5. Pets/animals of any type are not permitted, other than service dogs.
6. No bullhorns or megaphones, flashing lights or strobes, speakers or sound amplification is allowed.

LOAD IN/OUT PROCEDURES

1. Load in / set up begins daily at 2:00pm. You must be completely set up no later than 5:00pm - no exception. A staff host will greet you and be available to answer questions during your set up.
2. Load out will begin nightly starting at 9:30pm. Please work with your staff host to arrange for your vehicle to be allowed with a space closest to your assigned area.
3. If you are provided with a space near fire safety doors which will allow you with easy access to your personal vehicles you are asked to report any suspicious activity of customers trying to use the doors by your area to gain free access to the venue.
4. Be prepared to bring help, rolling carts, hand trucks to load into your booth space. Staff cannot be responsible for loading in, setting up or loading out vendor items.
